#### AVA Ski Trip 2027 - Santa Caterina, Italy

Following a successful ski trip to Bormio, Italy, I am in the process of planning for our return to Italy for a 2027 Ski Trip, this time to the Santa Caterina Resort.

The trip is being planned for March 2027 and will be confirmed upon confirmation of numbers for the trip. The estimated cost of the trip is £1450 per person, which includes:

- · Return flights and airport transfers
- 20kg luggage per person, per flight
- 6 nights full board accommodation
- 5 days area ski pass
- 5 x 5 hours skiing lessons
- · Equipment hire, including skis, boots, poles and helmets
- Travel insurance
- A company representative in the resort

If you wish to apply for a place on this trip, please complete the attached slip and return it to Mr Wakefield. If you are successful in securing a place, you will be notified by Mr Wakefield and a non-refundable deposit of £200 must be made through ParentPay within 7 days.

After this £200 deposit in November, there will be a payment for you to pay over the coming months. It will be around £150 a month, but this can of course be paid in higher increments or larger payments if you wish. The payment plan will be such to ensure that we can make full payment in January 2027.
